Sir,

- 1. I have the honour to report the proceedings of Her Majesty's New Zealand Ship WAIKATO during the period 1-30 November, 1966.
- 2. Testing and Tuning and Sea Trials have been progressed during the month in a generally satisfactory manner. The after effects of late supply of pieces of electrical equipment coupled with recently discovered design and wring faults is becoming a serious threat t the satisfactory completion of Sea Acceptance Trials in time to meet the Operational Date. Strenuous last minute efforts are now being made by authorities to prevent any further delays.
- 3. Sea Acceptance Trials commenced on 14 November and continued until 25 November on a day-running basis from Portsmouth. The flowing is a summary of results achieved: -

4. Further Sea Acceptance Trials including repeat trials where necessary are programmed for the period 8-22 December. Also in this period are included:

19 December Commander in Chief Inspection. (Normally taken to be the

Operational Date.)

20 December Final Reading of Form D. 448.

- 5. HMNZS SANTON arrived at Portsmouth on Saturday 5 November. Destoring, in preparation for paying-off was somewhat assisted by WAIKATO's Senior Rates who carried off all moveable non-accountable objects which were of any conceivable use to WAIKATO.
- 6. The Commander in Chief, Portsmouth, Admiral Sir Frank Hopkins, K.C.B., D.S.O., D.S.C., paid a return call on Captain Mercer on Wednesday 2 November and met the officers informally in the Wardroom. Captain Mercer call ed on Admiral Superintendent Portsmouth, Read Admiral R.C. Paige, on Thursday 8 November. This call is expected to be returned on Monday 5 December.
- 7. During Sea Trials on Thursday 17 November, Captain S.F. Mercer was placed on the Sick List and Lieutenant Commander T.A. Riddell assumed temporary command. Sea Trials continued as programmed without disruption.
- 8. The health and morale of the ship's company continues to be good. Morale was given an additional boost when the first 4.5" A.A. shoot scored a bulls eye and shot down the Rushton

Target. It is believed that this is the first time that a Rushton Target has been shot down at sea. Unfortunately, by the time the ship reached the splashdown area, the target which had disintegrated had largely disappeared and only one radar reflector ball was recovered.

- 9. The behavior of the ship's company has been generally good with some exceptions.
- 10. A separate report of sporting activities is at Appendix A and the miles steamed is at Appendix B.
